HEADTEACHER'S UPDATE

Dear Parents/Carers

After two weeks back at school, we are all now getting used to the new rhythm of our school day including following all our control processes. This week we have discussed our **tightening up together** approach as we look to minimise the impact on any closure to any groups. Please be mindful of any plans for half term and the potential impact on attendance/unauthorised absence due to quarantine requirements. We need all students in school each day. Thank you for your support.

Tightening up together

- **Hands** washing and hand sanitising our hands more often there are multiple hand sanitising stations in each block, hand sanitisers in each classroom and new stations on entry to the school are being installed for staff and students.
- Face the incorrect wearing and safe hygienic keeping of face coverings is a concern. We have reshared this video with students this week https://www.youtube.com/watch?v=9Tv2BVN_WTk and tried to help them understand the importance of wearing a face covering safely at all times
 - Changes from Monday
 - all students travelling on coaches will be required to place their facemask in a resealable bag once they step off the coach;
 - On entry into the school all students will be required to sanitise their hands;
 - Any student wishing to wear a face covering who travelled by bus, must use a new face covering once in school.
- **Space** we are asking staff and students to give each other space throughout the day, including at the start and end of the day to protect our bubble structure.

North Somerset have yesterday launched a campaign to encourage all of us to be responsible in our communities outside school to help keep us all safe.

Reminders from last week which are still all relevant:

In accordance with Gov.UK <u>Safeworking in education, childcare and children's social care</u> and our risk assessment, we ask all families to observe the following: to minimise contact with individuals who are unwell, if you are showing symptoms of coronavirus or have someone in your household who is, you should not be in a childcare setting, school or college. You should be at home, in line with the <u>guidance for households</u> with possible coronavirus infection





- Face coverings are a legal requirement when travelling on public transport for students in Year 7 and above. Students must wear face coverings on the buses as per our risk assessment and the legal requirement. No face covering will result in no travelling on the bus unless you have discussed this with school in advance due to the exceptions listed on gov.uk. Should you need support in obtaining a face covering, please contact us immediately.
- To help us manage the collection at the end of the day, please arrive at or after the departure time where possible to ease the congestion. We appreciate families with multiple siblings will overlap. Students must exit the site promptly and not gather at the top of school.
- To help us manage the entrance to school in the morning and protect our bubble structure, please do not drop your child/ren off until 8.40am.

A reminder of some important points to share with our community.

- (1) Should we have a positive case at St Katherine's School during the school term, we will be following advice from Public Health England, as per government guidance and our risk assessment. We will write to parents/carers immediately as part of this process.
- (2) Our year group bubble structure will help us reduce any impact on the school community. Our buses form a further bubble structure and in the event of a positive case, this will be included as part of our process.
- (3) We have 'interaction tracing' in place through Classcharts and through our allocated seating on buses (which has now settled down).
- (4) We have daily routines and control processes in place within our community and cleaning both during and at the start and end of each day to keep St Katherine's a COVID 19 safe environment. However, we recognise all schools are vulnerable and we all remain vigilant.

Road safety - cycling to school

It is great to see an increased number of students choosing to walk/cycle/scooter to and from school. However, we are deeply concerned at the lack of road safety awareness along with the absence of cycling helmets. We will be contacting families to discuss our expectations on anyone cycling to and from school.

There are a number of surveys we would welcome your response to this week. Please take a moment to complete them.

We are here to support all our young people with their learning at all times and please do not hesitate to get in touch if you need further support in any of the adjustments we are making. PARENT GOVERNOR VACANCY

Following the resignation of one of our long serving parent governors, the local governing body (LGB) is seeking expressions of interest from the St Katherine's parent/carer community in taking on this vital role.

Parent governors hold the unique position of having a parental viewpoint of the school. Through their children, they have a first-hand experience of the delivery of the curriculum, and how the school is perceived from the 'consumers' point of view. This enables parent governors to bring a different perspective to the strategic management of the school. This is reflected in the words of recent parent governors at St Katherine's:

As a parent/carer, you bring a special insight to the role of governor (this) can inform the questions to ask and add clarity to the discussions at board meetings. Mr Maw	All years	We are very grateful for the support we have received from parents and carers in our drive to uphold standards of uniform. Our current focus is on school shoes and we have seen a significant improvement in this area. We are aware that the current climate has left many of us less financially secure than was previously the case; if you are unable to purchase the correct school shoes due to financial concerns please speak with your child's Head of House who will be able to offer support. We do expect that all pupils are in shoes that comply with our uniform policy - if you are unsure whether the shoes you intend to purchase are suitable, please contact your child's Head of House.
Mr Francis Black	All Years	Transport - We now have a growing waiting list for our bus services and I am working with Turner's to explore the option of additional capacity from the start of term 2. To add your details to the waiting list please <u>click this link</u> .
Mr Francis Black	All Years	Lockers - As indicated in last week's newsletter we are actively pursuing options to replace locker provision for year groups that can no longer have access inside their designated block. We have been in contact with a company that is used by several other local schools and provides outside lockers which could then be accessed by all. The company works directly with families and hires lockers at a cost of £45 per year. We would like to gauge interest in this service before proceeding and would therefore ask that families complete our online survey. Mr Francis Black	All Years	Home IT Access - The last six months have shown us that when working from home, access to reliable IT is crucial. In order to safeguard the learning of all students we would appreciate it if you could take a few minutes to complete a survey of your home IT access. PE	All years	A reminder that students are able to wear PE kit to school on days where they have a PE lesson or club.

Year 11 Business	Year 11	Coursework catch up sessions will be running every Tuesday after school with Mr Bates in CR4. This is an opportunity for students to work on their coursework and gain additional support to achieve the best grades prior to submission at the end of Term 1.
Miss Richards	Year 11	We are awaiting confirmation of the 2021 GCSE exam dates. It is likely that exams will take place in June and July next year to ensure students are able to cover the curriculum. Please be aware of this when considering any summer holidays, Year 11 students will need to be present through June and July.
Miss Richards	Years 7-11	Students are continuing to complete a series of assessments in class this term. These are designed to provide the school with useful diagnostic evidence of strengths and weaknesses that your child may have. Please reassure your child that these tests are specifically designed not to require any prior revision and we do not wish them to be unduly worried about the process. If they are feeling anxious, please ask them to discuss this with their tutor.
		Whilst headphones are available to borrow in school, students are encouraged to bring their own small, bud type headphones to school. Headphones will be used in the assessments this term but may also be used in some subjects.
